#### **Invitation for Quotation (IFQ)**

1. You are invited to submit your priced bid for the tender of College Canteen at Upper Hostel

- 2. The bidder(s) must quote for all the items under this invitation. Price quotations will be evaluated for all the items and contract awarded to the firm offering the lowest evaluated bid.
- 3. The bidder(s) shall submit one original of the priced quotation with the Form of Bid and clearly marked ORIGINAL. In addition, the bidder(s) should also submit one copy marked as COPY. The quotation including all documents in the attached format should be sealed in an envelope and addressed to and delivered at the following address.

- 4. The deadline for receipt of your quotation(s) by the purchaser at the indicated address is on or before 31st January, 2020 at 10:00am and will be opened on same day at 10:30am in Conference hall.
- 5. The bid shall be accompanied by 20% of bid security from total bid amount (180,000\*20%=Nu. 36,000/-) of Nu. 36, 000 in the form of cash warrant, demand draft or unconditional Bank guarantee valid for one year. This is exclusive of the electricity bill. Any bid not accompanied by bid security shall be treated as non-responsive.



- 6. Quotations by fax or by electronic means are not acceptable.
- 7. Bidders have to fill up the menu forms in original as provided without using extra forms or sheets.
- 8. The quotation should be submitted as per the following instructions and in accordance with the attached Contract. The attached Terms and Conditions of Supply is an integral part of the Contract.
- **PRICE:** all prices shall be quoted in Ngultrum. **a**)
- **EVALUATION OF QUOTATION:** offers determined to be substantially responsive to b) the requirement will be evaluated by comparison of their quoted prices. In evaluating the quotations, the purchaser will determine for each quotation the evaluated price by adjusting the price quotation by making any correction for any arithmetical errors as follows;
- Where there is a discrepancy between amounts in figures and in words, the amount in (i) words will govern;
- where there is discrepancy between the unit rate and the line item total resulting from (ii) multiplying the unit rate by the quantity, the unit rate as quoted shall govern unless in the opinion of the Employer there is an obviously gross misplacement of the decimal point in the unit rate, in which case the line item total as quoted shall govern, and the unit rate shall be corrected.
- (iii) All the prospective bidders are required to quote as per the prevailing market rate. If any bidder quotes below 10% of the overall predetermined rates, bidder shall be considered as nonresponsive.
- (iv) If the supplier refuses to accept the correction, this quotation will be rejected and the bid security shall be forfeited.
- (v) Any bids received by the purchaser will be declared "late" and rejected.
- (vi) The selected bidder will be intimated in writing.

#### c) AWARD OF PURCHASE ORDER:



- i. Since the contract of award shall be awarded based on the grand total and not item wise, the bidders are asked to quote for all the items listed in the BoQ. Failure to quote for a single item will lead to rejection of bid.
- ii. The award will be made to the bidder who is offering the lowest evaluated price that meets the requirement. The successful bidder will sign a contract as per attached form of contract and terms and conditions of supply.
- **d) TERMINAION OF THE CONTRACT**: The purchaser may in written notice terminate the contract agreement in whole at any time for its convenience
- i. If the Supplier fails to perform any other terms and conditions specified with the contract agreement.
- ii. If the Supplier fails to perform any other obligation(s) under the contract agreement or
- iii. If the Supplier does not take any remedial action within a period of 7 calendar days after the receipt of a notice of default from the purchaser specifying the nature of the default (s)
- iv. If the Supplier in the judgment of the purchaser has engaged in any corrupt or fraudulent practices in competing for or in executing the tasks under this contract agreement.
- e) VALIDITY OF THE OFFERS: your quotation(s) shall be valid for a period of one year days from the deadline for receipt of award letter and subject to renewal base on the service provided.

- 10. The quotation(s) will be opened in the presence of bidders or their representatives who choose to attend at the specified venue and time.
- 11. The Purchaser is not bound to accept the lowest bid and reserves the right to accept or reject any or all the bids without assigning any reason whatsoever.
- 12. The bidder whose bid is accepted will be notified of the award of contract by the Purchaser prior to expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the supply order (sample form attached).
- 13. Payment will be made on submitting the bills/ invoice after completion of each activity.

#### Documents required to be submitted as part of the Quotation

### The original *copy* of quotation submitted by the supplier shall comprise the following:

- (a) A duly completed and signed priced quotation as per the Schedule of Items and the Priced Quotation.
- (b) A valid Trade License (If you have, if not the college license will be provided for the operation);
- (c) A valid Tax Clearance Certificate (Is required for those who have submitted the license);
- (d) The required bid security and
- (e) Any other requirements specified in this document
- (f) Copies of valid CID and Food Handlers license of the kitchen staff



#### **General Conditions of the Contract**

#### 1. Facilities:

- 1.1 The College will provide the canteen space.
- 1.2 The successful bidder has to buy the things of canteen available in the College.
- 1.3 The successful bidder has to purchase the things required.

Note: The prospective bidders are advised to inspect the canteen and its item physically.

#### 2. General Terms and Conditions

- i. The winning bidder shall be required to submit a bid amount of **Nu.180, 000 (One Lakh Eighty Thousand) only.** The bid amount shall be paid every month of Nu. 15,000/- as the rental charges where first rental of Nu. 15,000/- have to be paid during the signing of the contract.
- ii. The contract period for operating the canteen is for a term of one year and subjected to extension if services are found satisfactory.
- iii. The Operator shall be responsible for payment for the electricity bill.
- iv. The Operator should arrange their own logistics.
- **v.** Subletting of contract/license directly or indirectly is not permissible and may result in Pre-mature termination of contract or imposition of penalty, including forfeiture of security deposit.
- vi. The Operator shall not be permitted to make any structural additions/alterations to the facilities provided by the college without written sanctions from the College Management Committee.



vii. The Operator shall be responsible for maintenance of Canteen, electrical equipment provided by college. The facilities provided to the operator should be returned in good condition at the expiry/termination of the contract. However, for the major maintenance if required, college shall be responsible.



- viii. The Operator shall publish a menu card with agreed rates and shall not sell any item at a rate higher than the agreed rates in the contract. Operator shall ensure MRP of items NOT specified in the Menu.
  - ix. The Operator shall be responsible for providing all food/snacks/ refreshments items mentioned in the menu based on the quoted rate for all official catering and daily menu as and when required.
  - x. The operator shall handover all items as per the inventory list prepared at the initial handing taking over of the canteen facilities to the college. Any loss or damages to the facilities/property at the end of the expiry of the lease or upon termination, the operator shall either repair or replace and make good.
  - xi. The operator shall be responsible for payment of all applicable levies and taxes including BST and Services Charges. The operator shall be responsible for the license renewal and the filing of BIT if the college license is used.
- xii. The College Canteen Committee instituted (CCC) by college shall monitor the quality (cleanliness and hygiene) of food on regular basis.
- xiii. The canteen operator shall take corrective actions within 5 working days, given by the CCC in respect of feedback received from staffs and student of the college.
- xiv. The CCC shall conduct regular meeting with the canteen operator and staffs (monthly basis/quarterly) as and when required.
- xv. The canteen shall operate normally from 7:00 AM to 8:00 PM hours (Monday to Sunday). However, the operator should provide services beyond the above-mentioned time based on the requirement of the college; and
- xvi. Special permission shall be sought from the college to operate apart from college program within the canteen.
- xvii. College shall reserve to terminate the agreement at any time in-case of poor quality of food, services and hygiene which shall be determined by the CCCC.



- xviii. In special instances, college reserves the right to cater from different hoteliers/catering agents depending on the nature of guest and dignitaries visiting the college.
  - xix. The operator shall not impose service charges (i.e 10%) to college if catering service for the college is provided in canteen.

xxx. Bid amount shall be deposited to college finance section monthly wise (3rd day of the 3<sup>rd</sup> week of the month) without fail. Failing to deposit shall led to Nu. 500/- (Five Hundred) only as penalty for 1 day at the maximum of 10 days after which it shall led to termination of contract.

#### **Human Resources**

- 3.1 The operator shall employ adequate number of staff in-order to provide quality food and services desired.
- 3.2 The operator shall produce recent medical certificate of his/her employee/workers to be free from communicable diseases in addition to general fitness.
- 3.3 The Operator shall be responsible to provide workers with appropriate uniforms to the kitchen staffs and National dress to the waiters and managers and ensure neatness and cleanliness of the staffs.

#### 3. Hygiene and Cleanliness

- 4.1 The Operator shall ensure that they have Valid **Food Handlers' License** for all their kitchen staffs. In the event of the change in kitchen staff, the operator shall inform college of the change. The incoming staff shall mandatorily have to have **a** Valid Food Handlers' License. The operator shall be held accountable for any food poisoning/contamination.
- 4.2 The Operator shall be responsible for general cleanliness and hygiene of canteen facilities, crockery, cooking utensils in the kitchen. The garbage shall be disposed properly.



- 4.3 The Operator shall ensure the cleanliness of tablecloths, windows/doors curtain.
- 4.4 Cafeteria operator should not entertain any person inside the kitchen other than cooks and waiters.
- 4.5 The Operator shall not serve stale/expired food items. They shall ensure adequate tissue/napkin papers are placed on the dining tables.
- 4.6 The Operator shall display **NO SMOKING SIGN** in the canteen and shall not sell tobacco items, alcohol and other prohibited items in the canteen.
- 4.7 The operator shall be responsible to arrange all the logistic arrangement in case of venue requested outside canteen. Operator shall also be responsible to manage full time water in canteen even if there is water problem in campus.



#### **Contract Agreement**

- (e) The Supplier's Bid and original Price Schedules;
- (f) The Purchaser's Notification of Award of Contract;
- (g) The form of Performance Security;
- (h) The form of Bank Guarantee for Advance Payment;

- 3. Contract shall prevail over all other Contract documents. In the event of any discrepancy or inconsistency within the Contract documents, then the documents shall prevail in the order listed above.

The Purchaser hereby covenants to pay the Supplier in consideration of the provision of the Goods and Related Services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.
