**Terms and conditions other than the term of bidding documents**

The bidder must take care of roads blocks, strikes and halt at quarantine besides procuring agency. The bidders will not be paid for halt charges in any cases.

The quoted rate of a bidder is applicable only as per the movement authorization approved by the procuring agency.

The bidder must be responsible for any lossess or misplacment of goods during the time of transit.

The bidder must be responsible and ensure the vehicle given for hire is always in good condition.

The bidder must ensure that the driver concern should carry all the valid licenses and documents at the time of hiring period.

The quoted rate shall be inclusive of loading and unloading charges.

The driver must be free of any drinking habitual or drugs
